### Definition of Grades:

#### Grade (1)

All exposed solid parts such as top rims, base rails etc. (except decorative accents, inlays and parts) shall be the same specials as the face veneer. Top and bottom edges of drawer fronts shall be solid wood in the same species as the face veneers. Drawer sides and backs shall be solid wood. *All CCN products classify as Grade (1).*
